**SPCC RULES HAVE BEEN REVISED AND AMENDED**

**COMPLIANCE DEADLINE IS JULY 1, 2009**

**FINE FOR NON-COMPLIANCE: UP TO \$32,000 PER DAY, PER VIOLATION PURSUANT TO 33 USC Sec. 1319(d) OF THE FEDERAL CLEAN WATER ACT**

- **Who this applies to:** Facilities with aggregate above-ground oil storage capacity over 1,320 gallons (see [40 CFR 112.1\(b\)](#) for complete details on applicability).
- **What NEFI is offering:** An UPDATED web-based seminar (*webinar*) that covers the fundamentals of SPCC compliance: Plan review, revision and implementation by July 1, 2009. In addition, there will be a Q&A session after the webinar with our qualified experts.
